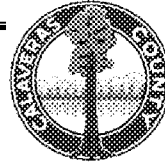

Section 12.08.120 states, "the applicant shall at all times comply with and shall cause all his agents and employees to comply with all such laws, ordinances, regulations, decisions, court and similar authoritative orders; and shall protect and indemnify the County and all of its officers, agents and employees against any claims of liability proximately caused by the violation of any such law, ordinance, regulations or order issued under police power and in accordance with law, whether by himself or by his agents or employees."

- _____ I agree to call for inspections of the work as noted in this permit.
- _____ I agree that construction of the encroachment will conform to the detailed drawings showing the County standards.
- _____ I agree not to pave or pour concrete without a grade or forms inspection.
- _____ I understand that additional inspections or re-inspections will be charged at the inspector's billable rate. This includes but not limited to re-inspections due to the encroachment location and/or property corners not being flagged or a correction notice issued by the inspector.
- _____ I agree to flag my proposed encroachment and my property corners at the County road.
- _____ I understand that the Certificate of Occupancy for the associated building permit will be withheld until the encroachment is constructed and approved by Public Works.
- _____ I understand that after completion of all work, I will be responsible for maintaining the area affected by the encroachment, including culvert maintenance.
